Dear Headright Owners,

The litigators for the Intervention just received this information and found something on it that we thought disturbing. Attached along with this letter is the docket for the ongoing trust case. On the face page that introduces the case where the tribe's demand is listed it reads the tribe demands "Demand: \$100,000,000 ", one hundred million dollars, rather than the 2.4 billion dollars claimed in the original suit. I would hope that our legal council or trust team board members would step forward and explain this.

I would encourage everyone to contact Mr. Pipestem, our attorney, or the members of the trust team, the minerals council plus the Chief and Archie Mason, for an explanation as to what happened to the other 2.3 billion dollars. There may be a simple explanation, but if there is we need to be informed of that rather than left to wonder and guess about what's taking place.

If, indeed, this is the amount that Mr. Pipestem and the trust team are seeking then we need to know why it's such a small amount. As things stand right now, with what little we know of this case, there is no reason that we should be settling for pennies on the dollar. This is too much money to just let go! \$2.3 billion plus dollars doesn't just get wiped off the table with no reason. If the trust team has decided to pursue a settlement of one hundred million dollars rather than the 2.4 billion, then we need to raise our voices and let it be known that is unacceptable.

We cannot remain quiet about this and hope things work out for the best. We cannot simply assume that everything being done in our name is in our best interest. We are the clients, we are the injured party and we must demand full disclosure from our attorney and the trust team that represents us.
